

MINUTES OF THE SELECTION COMMITTEE FOR NO. 1 FIXED-TERM AUTONOMOUS PRIVATE LAW CONTRACT FOR "LECTURER" FOR THE COMPETITION SECTORS 13/A1 POLITICAL ECONOMY AND 13/05 ECONOMETRICS IN THE DEPARTMENT OF ECONOMICS AT UNIVERSITÀ COMMERCIALE LUIGI BOCCONI IN MILAN.

Minutes no. 1

On 23 November at 9:00am, the Committee in charge of the comparative assessment for the conferral of no. 1 fixed-term autonomous private law contract, announced by Università Commerciale Luigi Bocconi on 5 October 2022, protocol no. 11955, met in virtual mode to cover the post of "Lecturer" for the competition sectors 13/A1 POLITICAL ECONOMY and 13/05 ECONOMETRICS for the evaluation of the applications received and the identification of candidates to be admitted to the teaching test.

The committee was composed as follows:

The Committee noted that 4 applications have been duly submitted. The applications were analyzed on the basis of the criteria expressed in the call for applications. In order to invite candidates to conclude the comparative assessment by holding an academic lecture, the CV, list of publications and titles presented by each were preliminarily assessed. The Committee focused in particular on the teaching experience related to the courses belonging to the competition sectors covered by the call. Following this assessment, the Committee expressed the following opinions:

Herbert Giovanni Leusch-Carnaroli earned a bachelor's degree in economics from North Carolina State University, before earning a Master in Security Management from George Washington University and another Master in Information Technology Project Management from the University of Maryland. Lastly, he obtained an MBA in Transportation and Logistics from the University of Maryland. He has extensive managerial experience in the private sector and has some scientific publications in both the field of air transport and information security. Regarding teaching, from what can be deduced from his curriculum vitae, the candidate has taught for many years on Information Security topics at Georgetown University and also Management courses at the University of Maryland. Specific teaching in the fields of the call for applications, namely Economia Politica (competition sector 13/01) and Econometrics (competition sector 13/05), cannot be inferred from his CV and attached titles.

Daniela Cialfi graduated with a degree in Economics and Computer Science for Business from D'Annunzio University in Chieti -Pescara, where she also obtained a Master in Management. She submitted several scientific publications on economic issues in journals and as contributions to collected volumes and has participated in research projects at the Department of Philosophical,



Pedagogical and Quantitative Economic Sciences at D'Annunzio University. She was a visiting post-doc at the Simons Center for the Theory of Computing at Berkeley University. In terms of teaching, since 2015 she has been holding training and seminars as a subject expert for courses in economics at D'Annunzio University where, in the academic year 2019-2020, she had a teaching contract for the course Economia Politica.

Gabriele Natale Deana holds a degree in Economic and Social Sciences from Bocconi University in Milan, where he also obtained a Master in Economics and a PhD in Economics. He has extensive teaching experience in economics at various universities in Italy. In particular, he has taught International Economics and Global Markets at Bicocca University in Milan, Financial Econometrics, Applied Econometrics and Economics at the University of Pavia, Econometrics and Financial Econometrics at the University of Genoa, Internationalization of Markets and International Markets, and Dynamic Macroeconomics at the Catholic University of Milan and Econometrics, Macroeconomics, International Economics and Econometric Analysis at Bocconi University.

Luigi Gaglione completed a degree in Sociology from the University of Urbino, before obtaining a Master in Healthcare Management at the LUM School of Management. He then attended several specialization courses in economics at various Italian universities. He has had a long and varied professional career in various fields, in particular pharmacology. Regarding teaching, he has carried out supplementary teaching activities for the Marketing and Business Communication course at the University of Turin. Since 2018 he has been Adjunct Professor of Economics and Business Management and also Private Law at the Ceglie Messapica branch of the Unicampus San Pellegrino University Foundation. Specific teaching in the fields of the call for applications, namely Economia Politica (competition sector 13/01) and Econometrics (competition sector 13/05), cannot be inferred from his CV and attached titles.

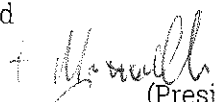
Based on the opinions, the Committee decided to admit the following candidates to the teaching test:

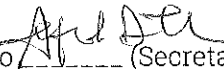
